Article 1

By signing this contract, the student agrees to provide a medical certificate of aptitude to follow osteopathic studies and attesting to the absence of any physical or psychological medical contraindication to practical (osteopathic manipulations) and clinical (internal and external internships) teaching in the context of studies at ECOM.

Article 2

The payment of the deposit is definitely acquired by ECOM. In addition, any year started is due in full. We remind you that the selected students enter in a restricted numerous classes and any abandonment represents a pace that another selected candidate cannot obtain. The deposit will be refunded only in case of failure to pass the high school diploma.

Article 3

In the event of non-payment on the scheduled dates or non-attendance of classes, the management reserves the right to suspend the students access to classes, which does not exempt the student from paying the full tuition fees for the current year.

Article 4

For the payment by instalments, the three bank transfer dates must be given at the beginning of the school year. ECOM undertakes to cash them on the dates stipulated in this contract. The expenses incurred on this choice are up to 150 €.

Article 5

The student has to provide his own liability insurance certificate each year to ECOM.

Article 6

At the beginning of the academic year, the student undertakes to provide an insurance certificate covering his civil liability for the current academic year as well as a medical certificate stating that the student is healthy enough to undertake osteopathic studies.
